ORDINANCE # 2019-03

AN ORDINANCE LEVYING AND ASSESSING THE TAXES OF THE PLAINFIELD TOWNSHIP PARK DISTRICT OF THE COUNTIES OF WILL AND KENDALL AND STATE OF ILLINOIS.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE PLAINFIELD TOWNSHIP PARK DISTRICT:

SECTION I

That, exclusive of any and all taxes authorized by acts which by their terms provide that such taxes shall be in addition to taxes for general purposes, the sum of THREE MILLION TWO HUNDRED THIRTEEN THOUSAND AND FOUR HUNDRED SEVENTY EIGHT AND NO/00 DOLLARS (\$3,213,478.00) is hereby levied and assessed for general corporate purposes upon all property subject to taxation within the Plainfield Township Park District at the full, fair cash value as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois for the state and county purposes as follows:

GENERAL FUND: Corporate Purposes

\$3,213,478.00

Said tax shall be in addition to the several other sums herein levied and assessed and shall be in addition to all other taxes authorized by law. Said tax shall also be in addition to the maximum of the taxes authorized by Section 5.1 of the Park District Code.

SECTION II

There is hereby levied and assessed the sum of ONE MILLION AND FIFTY THOUSAND DOLLARS (\$1,050,000.00), for recreational purposes upon all property subject to taxation within the said Plainfield Township Park District at full, fair cash value as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois for state and county purposes as follows:

RECREATIONAL FUND: \$1,050,000.00

Said tax shall be in addition to the several other sums herein levied and assessed and shall be in addition to all other taxes authorized by law. Said tax shall also be in addition to the maximum of the taxes authorized by Section 5.2 of the Park District Code.

SECTION III

There is hereby levied and assessed the sum of ZERO AND NO/ 100 DOLLARS (\$ 0.00), for Museum Fund purposes, upon all property subject to taxation within the said Plainfield Township Park District at the full, fair cash value as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois for state and county purposes as follows:

MUSEUM FUND: \$ 0.00

Said tax shall be in addition to the several other sums herein levied and assessed and shall be in addition to all other taxes authorized by law. Said tax shall also be in addition to the maximum of the taxes authorized by the Illinois Park District Code.

SECTION IV

There is hereby levied and assessed the sum of ONE HUNDRED SIXTY TWO THOUSAND NINE HUNDRED AND NINETY THREE AND NO/100 DOLLARS (\$162,993.00), upon all property subject to taxation within the said Plainfield Township Park District at the full, fair cash value as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois for state and county purposes to pay the costs of purchasing insurance to protect against any loss or liability which may be incurred by the said Plainfield Township Park District, all as provided by the "Local Governmental and Governmental Employees Tort Immunity Act," as follows:

LIABILITY INSURANCE FUND: Insurance Premiums Contracted \$162,993.00

Said tax shall be in addition to the several other sums herein levied and assessed and shall also be in addition to all other taxes authorized by law. Said tax shall also be addition to the maximum of the taxes authorized by the Illinois Park District Code.

SECTION V

There is hereby levied and assessed the sum of THREE HUNDRED SEVENTY ONE THOUSAND FOUR HUNDRED AND SIXTEEN AND NO/100 DOLLARS (\$371,416.00), for the Illinois Municipal Retirement Fund, upon all property subject to taxation within the Plainfield Township Park District at the full, fair cash value as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois for state and county purposes as follows:

ILLINOIS MUNICIPAL RETIREMENT FUND: \$371,416.00

Said tax shall be in addition to the several other sums herein levied and assessed and shall be in addition to all other taxes authorized by law. Said tax shall also be in addition to the maximum of the taxes authorized by the Illinois Park District Code.

SECTION VI

There is hereby levied and assessed the sum of ONE HUNDRED EIGHTY EIGHT THOUSAND FIVE HUNDRED AND FOUR AND NO/100 DOLLARS (\$188,504.00), for the Social Security Fund, upon all property subject to taxation within the Plainfield Township Park District at the full, fair cash value as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois for state and county purposes as follows:

SOCIAL SECURITY FUND:

\$ 188,504.00

Said tax shall be in addition to the several other sums herein levied and assessed and shall be in addition to all other taxes authorized by law. Said tax shall also be in addition to the maximum of the taxes authorized by the Illinois Park District Code.

SECTION VII

There is hereby levied and assessed the sum of ZERO AND NO/100 DOLLARS (\$0.00) for Police Services, upon all property subject to taxation within the Plainfield Township Park District at the full, fair cash value as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois for the state and county purposes as follows:

POLICE FUND:

\$0.00

Said tax shall be in addition to the several other sums herein levied and assessed and shall be in addition to all other taxes authorized by law. Said tax shall also be in addition to the maximum of the taxes authorized by the Illinois Park District Code.

SECTION VIII

There is hereby levied and assessed the sum of ONE MILLION ONE HUNDRED AND SIXTY THOUSAND EIGHT HUNDRED AND NO/100 DOLLARS (\$1,160,800.00), for the Special Recreation Fund, upon all property subject to taxation within the Plainfield Township Park District at the full, fair cash value as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois for the state and county purposes as follows:

SPECIAL RECREATION FUND:

\$1,160,800.00

Said tax shall be in addition to the several other sums herein levied and assessed and shall be in addition to all other taxes authorized by law. Said tax shall also be in addition to the maximum of the taxes authorized by the Illinois Park District Code.

SECTION IX

The recapitulation of the total taxes to be levied is as follows:

Making the aggregate sum of SIX MILLION ONE HUNDRED FOURTY SEVEN THOUSAND ONE HUNDRED AND NINETY ONE AND NO/100 DOLLARS (\$6,147,191.00), to be received by taxation levied on all the taxable property in said Park District, in order to meet and defray all the necessary expenses and liabilities of the Plainfield Township Park District as required by statute as voted by the people in accordance with the law.

The Secretary of the Plainfield Township Park District shall file with the County Clerk of the Counties of Will and Kendall, State of Illinois, a certified copy of this ordinance and said County Clerk shall ascertain the rate per centum which, upon the total value of all property subject to taxation within the said Plainfield Township Park District, at the full, fair cash value as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois for

state and county purposes will produce the net amounts herein levied and ordered certified, and he shall extend the tax upon the tax books of the collector of state and county taxes within the said Plainfield Township Park District as provided by Law.

SECTION X

This ordinance shall be in full force and effect from and after its passage.

Adopted this 13th day of November, 2019, pursuant to a motion made by Commissioner Ayres, seconded by Commissioner Rausch.



That attached hereto is a true and clear copy of the Annual Tax Levy Ordinance assessing taxes of the Plainfield Township Park District for the 2019 tax year.


